**RECOMMENDATION****1. That Council:**

- a. **Appoint Mr Glenn Inglis as Acting General Manager of Narrabri Shire Council from Monday, 20 June 2022;**
- b. **Authorise the Mayor to negotiate and sign a contract of engagement with Mr Glenn Inglis;**
- c. **Delegate to the Acting General Manager the same terms as the Council's delegations to the General Manager.**

**MAYORAL MINUTE**

Section 351 of the *Local Government Act 1993* holds that if the position of General Manager of the Council is vacant or the holder of such a position is suspended from duty, sick or absent, Council may appoint a person to the position temporarily.

At the Ordinary Council Meeting held 26 April 2022, Council reaffirmed its appointment of Mr Robert Ball as Acting General Manager from 11 May 2022. Due to prior personal commitments, Mr Ball will be unable to continue in the role of Acting General Manager from 18 June 2022.

Accordingly, Council is asked to appoint Mr Glenn Inglis to the role of Acting General Manager commencing Monday, 20 June 2022, until such time as the role is filled on a permanent basis.

Mr Inglis is known to the Narrabri Shire, having previously performed the role of Acting General Manager in 2015. Mr Inglis has had a long career in local government, commencing in 1973. Mr Inglis previously held the position of General Manager in a number of councils including; Broken Hill City, Parry Shire, Tamworth Regional, Armidale Regional, Tenterfield Shire, Uralla Shire, Coonamble Shire and Upper Hunter Shire.

Mr Inglis is a Graduate of the Australian Institute of Company Directors, holds a Graduate Diploma in Legal Studies, a Master of Business and a Graduate Diploma of Local Government. Mr Inglis is also a Board Director for StateCover Mutual Ltd.
